

These guidelines contain information that you need to be aware of when applying for an ACICIS semester program in Indonesia. Please contact the ACICIS Secretariat if you have any questions. **Additionally, do not complete this application without first reading the semester pre-departure guide for your chosen program. It contains valuable information on accreditation matters, visa conditions, pre-post program travel conditions, and other important matters.**

Application Closing Dates.

August-January Semester: 15 April.

February-June Semester: 1 September.

Applicants must submit all accompanying forms, guarantees and monies (as applicable) by the due date. Applications postmarked after the due date will only be considered under exceptional circumstances and may incur a late fee.

Visa and Travel Requirements

Applicants are required to have a passport valid for **at least 22 months from the application closing date.**

In Australia, all visa processing must be conducted via the ACICIS Secretariat (individual processing in Sydney or Canberra is not permitted).

For students from other countries or students travelling abroad prior to program commencement visas may be issued from overseas Indonesian consular missions (eg in Singapore). Applicants in this position should contact the Secretariat for advice.

APPLICANTS OBTAINING VISAS IN PERTH VIA ACICIS WILL BE WITHOUT PASSPORTS FOR 6 WEEKS PRIOR TO DEPARTURE.

APPLICANTS OBTAINING VISAS OVERSEAS MUST NOMINATE A PROCESSING POINT ON THIS APPLICATION. THIS CANNOT BE CHANGED ONCE APPLICATIONS ARE SUBMITTED.

ARRIVAL DATES ARE INFLEXIBLE. YOU MAY NOT ARRIVE IN INDONESIA MORE THAN THREE DAYS PRIOR TO THE COMMENCEMENT OF THE PROGRAM.

ALL APPLICANTS WILL BE WITHOUT PASSPORTS FOR UP TO TWO MONTHS AFTER ARRIVAL IN INDONESIA. NO OVERSEAS TRAVEL IS POSSIBLE DURING THIS PERIOD.

ALL APPLICANTS MUST ARRANGE THEIR EXIT PERMITS FROM INDONESIA TEN DAYS PRIOR TO FINAL DEPARTURE FROM THEIR CITY OF STUDY. YOU CANNOT SIMPLY LEAVE INDONESIA AT A TIME AND PLACE OF YOUR CHOOSING.

Carefully consider any pre or post program travel plans in light of these conditions. They are non-negotiable and ACICIS will not intercede on the behalf of applicants who make travel plans that clash with immigration requirements.

Accompanying Family Members

The spouse and children of participants may apply for a dependent visa as accompanying family. Application forms for accompanying family members are available for download from the the ACICIS website. Only married partners and children are eligible for dependent visas. Non-married couples should contact the Secretariat for possible alternative arrangements.

Course Accreditation

ACICIS will provide a student's home university with two assessment documents:

1. **Official academic transcript** from the Indonesian host university consisting of a numeric or alphabetic grade for each subject undertaken;

2. **Resident Director's Report.** The Resident Director (RD) provides a one-page report outlining a student's academic performance and extra-curricular involvement. The report is based on the Resident Director's contact with a student throughout the course of the program and on a final exit interview. In accordance with standard ACICIS practice, overall student performance will be assessed by the RD only on a "satisfactory/unsatisfactory" basis (equivalent to "ungraded pass/fail"). A student's home university retains the right to require and grade further assessment tasks, including a portfolio or reflective diary summarising the student's in-country experience.

Electronic copies of a student's assessment documents will be mailed to the student's home university **within three months** of the conclusion of the semester program. Private participants will have their results forwarded to them via email. Advance electronic copies of a student's results may be made available earlier. Please contact the ACICIS Secretariat for details. Priority cases can be managed for students who are due to graduate or require them for urgent re-enrolment purposes. If you require priority processing of semester results, please notify the ACICIS Secretariat as soon as possible so that steps can be taken to expedite their release.

There is a AUD\$50 fee for the re-issuance of official university transcripts.

Withdrawal

All arrangements for student withdrawal from ACICIS courses are determined by the Indonesian institution at which they are enrolled and by the regulations in force at their home university. Withdrawal from or non-attendance at courses may result in students being given a "fail" grading.

Tuition fees will not be refunded after commencement of orientation. In the case of Australian students, these dates differ from normal HECS/HELP withdrawal dates so although students can withdraw at any time, home institutions may not withdraw HECS/HELP liabilities as payment will have already been made on students' behalf.

Home universities may require applicants to repay tuition fees to the university in the event of withdrawal.

The ACICIS Secretariat requires written notification of withdrawal before departure.

Disclaimer

Indonesian government and university regulations and fees may change at any time without notice, and are beyond the control of ACICIS. ACICIS reserves the right to pass on to participants any Indonesian government or university price increase up to the commencement of the orientation period. Participants will be expected to cooperate with the Secretariat when advised that such changes have occurred.

Administration Fee

The compulsory **AUD\$948 administration fee** incorporates costs for visa processing, student orientation and continuing support services as outlined below:

AUD\$250	Compulsory three-day live-in orientation on arrival in Indonesia. Accommodation and meals are provided during orientation; additional organised semester activities
AUD\$185	Application processing fee
AUD\$348	Issue of a study permit, 12-month temporary residence visa, 6 month multiple exit re-entry permit, and other costs involved in registering students with relevant Indonesia authorities such as police and local government
AUD\$165	Visa issuance fee for processing of VITAS (study) visa at Indonesian Consulate in Perth. For students from countries other than Australia or Australian students travelling abroad prior to program commencement visas may be issued elsewhere (eg. in Singapore) and paid directly to the issuing consulate/embassy. Please note that visa issuing costs vary between individual embassies and consulates and may be different to the cost stated here.

Students are required to pay their administration fee **only upon successful acceptance into their nominated ACICIS program.**

Tuition fees must be paid at least one month prior to student departure for Indonesia. Tuition fees are non-refundable after the start of orientation.

All costs associated with the ACICIS program, including the administration fee and all other expenses incurred obtaining a passport, organising travel to and from Indonesia, etc are the responsibility of the applicant.

Students are required to pay their administration fee **only upon successful acceptance into their nominated ACICIS program.** Upon acceptance students will be emailed an online payment link for the purposes of settling their application payment by credit card. Regrettably, only Visa and Mastercard are accepted.

A second payment link pertaining to payment of the ACICIS tuition fee will be sent to those students responsible for paying their tuition fee directly to ACICIS (i.e. where the tuition fee is not being paid on a student's behalf by their home university). Many Australian ACICIS [member universities](#) pay this tuition fee on their student's behalf, allowing Commonwealth-supported students to defer the expense on HECS-HELP. If you are unsure as to whether this applies to you, please contact your home university's study abroad office or the ACICIS Secretariat.

Financial Help

2. VISA INFORMATION (please read carefully)

ACICIS students enter Indonesia on a 12-month VITAS (Visa Izin Tinggal Terbatas) Temporary Stay Visa. ACICIS will organise the required paperwork to apply for this visa. Once this paperwork is provided by the Indonesian authorities, you have two options to have your visa sticker issued into your passport. Please select your place of visa issue carefully, as this typically cannot be changed following your final program acceptance:

1. Obtain your visa in Australia (Perth) with the assistance of the ACICIS Secretariat

For most Australia-based students, visas are processed - in bulk - by ACICIS through the Indonesian Consulate in Perth. Students are required to courier their passports to the ACICIS Secretariat six weeks prior to departure for Indonesia. Once visas have been processed, ACICIS couriers passports back to students in time for departure.

The timeframe for visa processing via the ACICIS Secretariat varies considerably from semester to semester and is beyond ACICIS' control. Therefore students are strongly advised not to plan any travel overseas for the six weeks immediately prior to their semester in Indonesia. Please note that due to regulations, ACICIS can only offer this service to Australian passport holders, New Zealand passport holders and other nationalities in possession of an Australian visa valid until/beyond the ACICIS program start date.

2. Obtain your own visa outside Australia

Students resident in other countries or those travelling abroad during the six weeks prior to program commencement may have their VITAS visa issued at an Indonesian consular mission located outside Australia. In most cases, students in this position apply for their Indonesian visa at the Embassy or Consulate located closest to their place of residence (non-Australian residents only) or in Singapore (all nationalities) during the period immediately prior to their semester start date. Applicants in this position should contact the ACICIS Secretariat to discuss their options and to make sure their nominated visa pick-up point is possible.
